



STATUTORY DECLARATION
Statutory Declarations Act 1959

I, Paul Andrew Breckenridge 96A Murrumbeena Rd Murrumbeena VIC 3163, Managing Director of Katrina's Kitchen make the following declaration under the *Statutory Declarations Act 1959*

- 1 All persons over the age of 16 who are employed, hired, retained or contracted by Katrina's Kitchen in providing our service of delivering meals to care recipients who will have or are reasonably likely to have unsupervised access to the care recipients have:
 - (a) a police certificate that is dated not more than three (3) years before the first day on which the staff member is to provide services under the contract; and
 - (b) the Police Certificate does not record that the staff member has been:
 - (1) convicted of murder or sexual assault; or
 - (2) convicted of and sentenced to imprisonment for any other form of assault.
- 2 If a staff member had been at any time since she or he turned 16 a citizen or permanent resident of a country other than Australia that person has made a Statutory Declaration stating that they have never been:
 - (1) convicted of murder or sexual assault; or
 - (2) convicted of and sentenced to imprisonment for any other form of assault.
- 3 All original or certified copies of Police Certificates and all original Statutory Declarations pursuant to paragraphs 1 and 2 above are in the possession of Katrina's Kitchen and are summarised below:



- 4 No person will be allowed to continue as a staff member if there is for that person a Police Certificate or Statutory Declaration that records that person has been:
 - (1) convicted of murder or sexual assault; or
 - (2) convicted of and sentenced to imprisonment for any other form of assault.
- 5 Each staff member has been assessed as suitable to deliver meals to people in aged care having regard to any Criminal history disclosed by the Police Certificate or the staff member.
- 6 I am authorised to make this declaration by Katrina's Kitchen and do so from my own direct knowledge.

I understand that a person who intentionally makes a false statement in a statutory declaration is guilty of an offence under section 11 of the Statutory Declarations Act 1959 and I believe that the statements in this declaration to be true in every particular.

NOTE 1 – A person who intentionally makes a false statement in a statutory declaration is guilty of an offence, the punishment for which is imprisonment for a term of 4 years – see section 11 of the *Statutory Declarations Act 1959*.

NOTE 2 – Chapter 2 of the *Criminal Code* applies to all offences against the *Statutory Declarations Act 1959* – See section 5A of the *Statutory Declarations Act 1959*
